TERMS AND CONDITIONS

This 2-page document enumerates key points to be considered when you're visiting or booking a programme at Art Village Karjat for your group.

Signing this document suggests that you and your group are well aware of, respect and agree with the decorum and rules we have at AVK.

PROPERTY AND LIABILITY RELATED

- 1. AVK kitchen has timings and meals are served within those timings only.
- 2. No damage to the property and its items are tolerated. If any damage is noticed by the AVK onground team, the compensation for it will be monetary.



- 3. There is a swimming pool on the project. The is no lifeguard on duty. One must use the pool with discretion. Children under 12 cannot use the pool unaccompanied by an adult. AVK is not liable for any mishaps/accidents caused while using the pool.
- 4. AVK is an animal friendly project and there are some wild and domestic animals on the land. AVK does not tolerate harm or trouble in any way done to them. One must interact with the animals with discretion and sensitivity. AVK is not liable for any accidents with respect to the animals and fauna of the land.
- 5. There is no room service and food is not allowed in the rooms. We do not allow snacking in the rooms as it invites insects and reptiles. Children can store their carried snacks in the kitchen area and eat it in the dining space.

PROGRAMME RELATED

- 1. The purpose of AVK is to empower the artist, and this is of utmost importance to any programme conducted at AVK. The practicing artists are collaborators with AVK. Therefore, when one signs up for a workshop, respect to the artists and facilitators is expected. Any disrespectful or rude behaviour will not be tolerated.
- 2. During the course of the programmes, alcohol consumption and/or any intoxication done by accompanying adults will not be tolerated.
- 3. If a certain pre-decided time has to been alloted for the programme, the timings need to be followed. It is not AVK's liability if the artist needs to modify the programme time or leave, due to late attendance of the group.
- 4. Tough and stimulating conversations are a part of our artistic programmes. If there is something that makes you uncomfortable, there should be healthy debate about the same. We don't restrict the artists' programmes.

LOGISTICS

- 1. Any medical history (relevant to an overnight stay) or need for special assistance has to be communicated to the
- 2.AVK team via e-mail a week prior to the booking.
- 3.All art programmes, artist conveyance and materials are paid for separately by the group. If any equipment needs high power supply, an external genset will be required. This cost will be borne by the group and not AVK.
- 4. Menus are made based on the food requirements, dietary restrictions and food allergies submitted by the 5. school/group representative a week prior to the booking.
- 6.Room allocations are as per discretion of the school/group representative.
- 7.Self help and self service is an important aspect of our philosophy at AVK. Basic clean up of one's space after the programme is expected from every member of the group.
